# TAX PENALTY

A 16% tax penalty will be levied on all outstanding properties after January 15, 2023. This includes utility transfers, current and arrear taxes and any other balance on the tax roll.


#### REMINDER FROM ENFORCEMENT SERVICES

A friendly reminder from your Community Peace Officer. As a resident of the Town of Millet, all persons within the Town of Millet owning, controlling, or occupying property that adjoins any

sidewalk shall remove or cause to be removed and cleared away all snow, ice, dirt, debris or other material from any sidewalk adapted to the use of pedestrians. Such removal shall be completed within 72 hours from the time that the snow, ice, dirt, debris, or other material was formed or deposited

Any person who fails to comply with this section is guilty of an offence and may be issued a violation ticket or traffic tag by a Peace Officer in an amount specified in Schedule A of the Bylaw. In default of any person complying with subsection above, and in addition to any other remedy available to the Town of Millet for noncompliance with the bylaw, the Town may arrange to have the sidewalk cleared and any cost thereof shall be paid to the Town upon demand and failing payment, such cost shall be charged against the property as a special assessment.
